AGENDA City Council Meeting 2-19-07

The City Council of Nebraska City met in the Council Chambers on February 5, 2007 at 6:00 pm. Mayor Adelung led in the Pledge of Allegiance then called the Public Hearings to order. On roll call the following were present: Commissioners Schiermeyer, Handy, Friesen, Mercer and Mayor Adelung.

- 1. **Public Hearing** on a Special Designated Liquor License for Knights of Columbus for Lourdes event on March 17, 2007. Jeff Funke presented the request to council. Commissioner Friesen moved to close Public Hearing #1, seconded by Commissioner Schiermeyer. Council moved unanimously to close Public Hearing #1.
- 2. **Public Hearing** to consider a Redevelopment Plan, including a Downtown Revitalization Concept Plan and implementation tools for Nebraska City. Mayor Adelung asked to move original agenda item #6 up to #2 to allow Marty Shukert of RDG Planning and Design to present earlier on the agenda due to a family emergency. Marty presented a power point presentation on the Downtown Nebraska City Plan and the Revitalization Plan for Nebraska City. Marty presented for 53 minutes. Commissioner Mercer moved to close Public Hearing #2, seconded by Commissioner Handy. Council moved unanimously to close Public Hearing #2.

Commissioner Handy moved to close Public Hearing #7, seconded by Commissioner Friesen. Council moved unanimously to close Public Hearing #7.

Mayor Adelung moved to close all Public Hearings and to move in to the Regular Council Meeting at 7:20 p.m. On roll call the following were present: Commissioners Handy, Friesen, Mercer, Schiermeyer and Mayor Adelung. The Regular City Council Meeting session opened at 7:21 p.m.

Mayor Adelung read a Proclamation from Choice Treatment Center, Inc. to declare March as Gambling Awareness Month.

REPORTS

Scott Bovick gave a brief City Administrator's Report. Mr. Bovick stated that the Department Heads for the City will be meeting held on March 16th at 8:00 a.m. at the Lewis and Clark Center. Mr. Bovick also stated that bids have gone out for the demolition of the Bob Barton Property. Dan Giittinger also came forward to discuss the recent snow removal and he reminded people that the snow blades do not have any down force and when it has been so cold and wet the removal can be problematic since the salt and sand combo do not react until he temperatures reach the upper teens.

Roger Watton of BKD presents City of Nebraska City Annual Financial Statement for 2005/2006 Fiscal Yr. and reported that all of the items mentioned in his letter to council have been acted on and corrected. Mr. Watton stated that the recent overhaul of the budget document and cleaning up of the accounting system have proved to be worth while and commended Scott Bovick and Shay Sailors for their efforts in achieving this goal. Mr. Watton stated that he was in favor of the Treasurer's new Accounting Procedure Manual and encouraged the City Administrator to double check items of accountability as well.
