CITY COUNCIL PROCEEDINGS January 21, 2008

The City Council of Nebraska City met for a Public Hearing on January 21, 2008 at 6:00 p.m. in the Council Chambers at City Hall. Mayor Adelung led in the Pledge of Allegiance. Mayor Adelung then called the Public Hearing to order and on roll call the following answered present: Dean Handy, Mark Mercer and Mayor Jo Dee Adelung. Absent: Leon Schiermeyer and Erv Friesen. City Administrator Scott Bovick presented street and bridge projects either slated for bid letting in 2008 or that bids had already been awarded for the 2008 construction season. Even Wickersham, P.E. was also present to answer any questions. No one else spoke in support or against the plan. Commissioner Handy moved to close the Public Hearing, seconded by Commissioner Mercer. Upon roll call the following voted YEA: Mercer, Handy and Mayor Adelung. Voting NAY: None. Absent Friesen and Schiermeyer. Motion carried.

The City Council of Nebraska City then met for the regular monthly meeting. Mayor Adelung called the City Council Meeting to order and on roll call the following answered present: Dean Handy, Mark Mercer and Mayor Jo Dee Adelung. Absent: Erv Friesen and Leon Schiermeyer.

Notice of this meeting was given in advance thereof by posting in at least three public places, the designated method for giving notice, as shown by the Certificate of Posting Notice attached to these minutes. Notice of this meeting was given to the Mayor and all members of the City Council and a copy of their acknowledgement of receipt of notice and the agenda is attached to these minutes. Availability of the agenda is communicated in the advance notice to the Mayor and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Commissioner Handy moved to approve the minutes from the January 7, 2008 Special Joint Meeting with the Board of Public Works. Commissioner Mercer seconded the motion and on roll call the following voted YEA: Mercer, Handy, and Mayor Adelung. Voting NAY: None. Absent: Schiermeyer and Friesen. Mayor Adelung declared the motion carried.

Commissioner Handy moved to approve the minutes from the January 7, 2008 Regular Council Meeting. Commissioner Mercer seconded the motion and on roll call the following voted YEA: Mercer, Handy, and Mayor Adelung. Voting NAY: None. Absent: Schiermeyer and Friesen. Mayor Adelung declared the motion carried.

Mayor Adelung proclaimed January 27th through February 1st as "National Catholic Schools Week."

Mayor Adelung proclaimed March as "Gambling Awareness Month."

Mayor Adelung proclaimed January 20th to January 26th as "Nebraska City Jaycee Week."

Mayor Adelung recognized several employees for their years of service. Marvin Bando, Doug Bennett, Dan Giittinger, Mary Wallen and Gary Bassinger each had 5 year service awards. Jeff Lant received his 10 year service award. And LaVonda Bando received recognition for 20 years of service. The Mayor praised all these employees for their service and dedication to excellence.

City Administrator Scott Bovick, reported that the Public Safety Building Committee selected two (2) firms out of all the applicants to interview to be the architects for the construction project. Mr. Bovick also reported that interior demolition will begin shortly which will possibly save the City \$10,000.00 to \$12,000.00. He also said that interviews for the Nebraska City Main Street manager would be soon and that there were several good applicants.

Traci Reuter and Shawna Silvius informed the Council of programs available to community and county residents including the progress of "Partners for Otoe County" and the new CAPE Program (Community Assisted Parenting Education). These programs were made possible by grants from Catholic Initiatives and United Way.

Mayor Adelung introduced Resolution 2349-08 which accepts and adopts the One and Six Year Plan for Street Improvement Program for the City of Nebraska City. Upon roll call the following voted AYE: Handy, Mercer and Mayor Adelung. Voting NAY: None. Absent: Friesen and Schiermeyer.

Police Chief Dave Lacy, informed the Council of a \$3,500.00 grant the department received from the Department of Highway safety for an "In-Car" digital video system for the new patrol car.

Fire Chief Alan Viox, informed the Council of grants recently received by the Nebraska City Fire Department. They received \$64,010.00 from FEMA for communications equipment, \$139,000.00 for Self-Contained Breathing Apparatus' and \$2,450.00 from United Way for Public Fire Extinguisher Training.

Mayor Adelung introduced the second reading of Ordinance 2714-08, an ordinance to amend Section 34-85 of the Code of Nebraska City, Nebraska, to levy an Occupation Tax of three percent on the gross receipts of telephone and telecommunication services in the City of Nebraska City, Nebraska.

Mayor Adelung then introduced Ordinance 2715-08 an ordinance to add a new section to the Code of Ordinances of the City of Nebraska City, Nebraska, to provide for the transfer funds from the Electric and Natural Gas Combined Utilities Fund to the General Fund of the City of Nebraska City, as provided by Section 1 hereof; to repeal any ordinances in conflict with this ordinance and to declare an effective date and moved that the statutory rule requiring reading on three different days be suspended, seconded by Commissioner Handy. Upon roll call the following voted AYE: Handy, Mercer and Mayor Adelung. Voting NAY: None. Absent: Friesen and Schiermeyer. Mayor Adelung declared the motion adopted by three-fifths (3/5) vote of the Council and the Statutory Rule suspended for consideration of the ordinance.

Said ordinance was then read by title and thereafter Mayor Adelung moved for final passage of the ordinance. The Mayor stated the question: "Shall Ordinance 2715-08 be passed and adopted?" which was seconded by Commissioner Mercer. Upon roll call the following voted AYE: Handy, Mercer and Mayor Adelung. Voting NAY: None. Absent: Friesen and Schiermeyer. The passage and adoption of said ordinance having been concurred in by the majority of all members of the Council, the Mayor declared the ordinance adopted and the Mayor in the presence of the Council, signed and approved the ordinance and the clerk attested the passage and approval of the same and affixed his signature thereto.

A true and correct copy of said ordinance is as follows:

ORDINANCE NO. 2715-08

AN ORDINANCE TO ADD A NEW SECTION TO THE CODE OF ORDINANCES OF THE CITY OF NEBRASKA CITY, NEBRASKA, TO PROVIDE FOR THE TRANSFER OF FUNDS FROM THE COMBINED UTILITIES FUND TO THE GENERAL FUND OF THE CITY OF NEBRASKA CITY, AS PROVIDED IN SECTION 1 HEREOF; TO REPEAL ANY ORDINANCES IN CONFLICT WITH THIS ORDINANCE AND TO DECLARE AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND CITY COMMISSIONERS OF THE CITY OF NEBRASKA CITY, AS FOLLOWS:

<u>Section 1.</u> That Chapter Thirty-one, Article II, Section 31-37, be added to the Code of Ordinances of the City of Nebraska City, Nebraska, which shall read as follows:

"Section 31-37. <u>Transfer of funds.</u> That commencing on the first day of September, 2007, and quarterly thereafter, the City of Nebraska City shall transfer from their Combined Utilities Fund to the General Fund of the City of Nebraska City, three percent of the gross revenue received from the electric

energy and natural gas sales from customers residing within the corporate limits of the City of Nebraska City. Such funds shall be transferred within thirty days of the end of each calendar quarter."

Section 2. That all ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

Section 3. That this Ordinance shall be in full force and effect from and after its passage, approval, and publication, as provided by law.
