CITY OF NEBRASKA CITY, NEBRASKA MINUTES OF CITY COUNCIL REGULAR MEETING September 21, 2009

Pursuant to due call and notice thereof, a Regular Meeting of the City Council of the City of Nebraska City was conducted in the Council Chambers of City Hall, 1409 Central Avenue, on September 21, 2009. Notice of the meeting was given in advance thereof by posting in at least three public places, the designated method for giving notice, as shown by the Certificate of Posting Notice attached to these minutes.

Mayor Hobbie called the meeting to order at 6:00 p.m. The Mayor publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and indicated the location of such copy posted in the room where the meeting was being held. Mayor Jack Hobbie led in the Pledge of Allegiance. Upon roll call the following answered present: Jeff Crunk, Dean Handy and Mark Mercer. Absent: Brett Gay. The following City Officials were present: City Administrator Pat Haverty, City Clerk Arnold M. Ehlers, City Attorney William Davis, Police Chief David Lacy, Building Inspector Alan Viox and Public Properties Director/Zoning Director Dan Giittinger.

Commissioner Handy moved to approve the minutes of the September 8, 2009, City Council Regular Meeting, seconded by Commissioner Crunk. Upon roll call the following voted AYE: Crunk, Handy, Mercer and Mayor Hobbie. Voting NO: None. Absent: Gay. Motion adopted.

Commissioner Handy moved to approve the minutes of the September 14, 2009, City Council Regular Meeting, seconded by Mayor Hobbie. Upon roll call the following voted AYE: Handy, Mercer and Mayor Hobbie. Voting NO: None. Absent: Gay. Abstain: Crunk. Motion adopted.

Mayor Hobbie proclaimed the week of September 20 – 26, 2009 as ""Women of Today Week."

Pat Haverty reported the status of the 11th Street/11th Corso project, stating that it appears that Nebraska City is still eligible for "stimulus" funding. The Central Avenue Project is officially a "stimulus" project. The community survey concerning the Memorial Building will begin October 15th and the Morton-James Public Library boiler has been sent back to the factory for repair or rebuilding. The Treasurer reported that there was \$3,141,172.66 on hand at the beginning of the month, the city received \$1,057,222.97 and had expenditures of \$1,521,393.27 leaving a balance of \$2,677,002.36. Wyuka Cemetery received \$5,616.50 in the month of August. Chief Lacy presented the Council with the most recent Quarterly Report. The Mayor accepted the reports and asked that they be placed on file.

Chief Lacy introduced the newest member of the Nebraska City Police Department. Officer Dean Scheideler. Officer Scheideler was given the oath of office by City Clerk Arnold M. Ehlers.

Chief Lacy requested that the multi purpose room at the new police station be named the "Gary White Conference Room" in honor of the only Nebraska City Police Officer to lose his life while on duty. Commissioner Handy moved to approve the naming of the multi purpose room at the Police Station the "Gary White Conference Room." Upon roll call the following voted YES: Crunk, Mercer, Handy and Mayor Hobbie. Voting NO: None. Motion passed.

Laura Crook of the Nebraska City Jaycees requested use of the concession stand on October 3 for a Jaycee Fund Raiser. Commissioner Crunk moved to approve the use of the concession stand by the Jaycees on October 3rd. Upon roll call the following voted YES: Mercer, Handy, Crunk and Mayor Hobbie. Voting NO: None. Tammi Thompson of St. Mary's Community Hospital requested using city parks and streets for a Cancer Awareness Fun Run/Walk on October 10, 2009. Pat Haverty presented six (6) applications for housing rehab funds recommended for approval by SENDD. Commissioner Handy moved to approve the applications recommended for approval by

Henry Hughson III made a written request to have "Children Playing" signs placed on the 700 block of 10th Corso. Commissioner Mercer moved to table the request pending additional information from the Public Properties Director and Mr. Hughson. Upon roll call the following voted YES: Crunk, Handy, Mercer and Mayor Hobbie. Voting NO: None. Motion carried.

Henry Hughson III made a request to purchase the two (2) City owned lots adjoining his property. Commissioner Mercer moved to table the request pending additional information concerning location of flood plain in relation to lots and intended use of lots. Upon roll call the following voted YES: Crunk, Handy, Mercer and Mayor Hobbie. Voting NO: None. Motion passed.

Roy Schneider of Friendship Villa requested 12th Street North of 3rd Avenue be closed for a Block Party on October 2, 2009 from 4 p.m. to 9 p.m. Commissioner Handy moved to approve the request to close 12th Street North of 3rd Avenue on October 2nd from 4 to 9 p.m. for a Block party. Be It Ordained by the Mayor and the City Commissioners of the City of Nebraska City, Nebraska as follows:

Section 1. That Section 33-78.5 of the Code of Nebraska City, Nebraska, be amended to read as follows:

"Sec. 33-78.5 Disposition of snow and ice incident to clearing sidewalks, drives and parking lots.

It shall be unlawful for any person to dispose of, or cause to be disposed of, any snow or ice on or against a fire hydrant or upon any street or roadway, except that in such locations where there is no parking area between the sidewalk and the street, the snow and ice removed from only the sidewalks may be placed in the parking area of the street, if done before the street is plowed by the City's street maintenance crews. Tractors and pickups with blades attached shall not be used for snow removal from sidewalks and any damage caused by such snow removal equipment to the walk or curb shall be repaired by the property owner. Damage caused to City snow removal equipment by concrete or other foreign matter placed in the street will be assessed to the adjacent property owner."

Section 2. That the original section 33-78.5 of the Code of Nebraska City, Nebraska, and all other ordinances or parts of ordinances in conflict herewith, be and the same are hereby repealed.

Section 3. That this Ordinance shall be effective from and after its adoption, approval, and publication, as provided by law.

All fees collected under the provisions of this division are hereby declared to be occupation tax money levied for revenue purposes; shall be credited to the general fund of the city and shall be used to defray the cost of expenses of administering this article and thereafter for general purposes."

"Sec. 33-78. Duty of owner or occupant to keep abutting sidewalk clear and free.

Every owner or occupant of any house or other building, or the owner or proprietor, lessee, or person entitled to the possession of any vacant lot, and any person having charge of any church, jail, or public hall, or public building in the city, shall during the winter season, and during the time snow and/or ice shall continue to fall, shall within twenty four hours (24) of such event clear the sidewalks in front of such lots, from snow and ice, and keep such sidewalks free from snow and ice during the day, or in case the snow and ice are so congealed that they cannot be removed without injury to the sidewalk, shall cause the said snow and ice to be strewn with sand and shall also at all times, keep such sidewalks clear and free from all dirt or filth, or other obstructions, so as to allow pedestrians to use the said sidewalks with safety. Failure on the part of any person upon whom a duty is placed by the provisions of this section to perform such duty shall be deemed a misdemeanor."

Section 2. That the original section 33-78 of the Code of Nebraska City, Nebraska, and all other ordinances or parts of ordinances in conflict herewith be and the same are hereby repealed.

Section 3. That this Ordinance shall be effective from and after its adoption, approval, and publication, as provided by law.
