The City Council of Nebraska City met in regular session on August 6, 2007, immediately following the public hearing in the Council Chambers at City Hall. Mayor Jo Dee Adelung called the meeting to order and on roll call the following answered present: Leon Schiermeyer, Dean Handy, Erv Friesen, Mark Mercer and Mayor Jo Dee Adelung.

Notice of this meeting was given in advance thereof by posting in at least three public places, the designated method for giving notice, as shown by the Certificate of Posting Notice attached to these minutes. Notice of this meeting was given to the Mayor and all members of the City Council and a copy of their acknowledgement of receipt of notice and the agenda is attached to these minutes. Availability of the agenda is communicated in the advance notice to the Mayor and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Commissioner Friesen moved to approve the minutes of the July 16, 2007 meeting. Commissioner Handy seconded the motion and on roll call the following voted YEA: Handy, Friesen, Mercer, Schiermeyer and Mayor Adelung. Voting NAY: none. Mayor Adelung declared the motion carried.

Mayor Adelung proclaimed August 18, 2007 as Disabled American Veterans Forget-Me-Not day.

The City Administrator, Scott Bovick, updated the council on the Lied Main Street program.

The following reports were presented for Council consideration: Wyuka Cemetery report for July: Sales, \$700.00; Interments, \$2375.00; Misc. \$1133.50; Memorial Bldg. Receipts for July; \$65.00; City Treasurer's monthly report: Balance on hand July 1, 2007: \$21,623,738.27; Receipts: \$3,807,133.54; Disbursements: \$3,798,167.27; Balance on hand July 31, 2007: \$21,632,704.54. Commissioner Handy moved to approve the reports as presented. Commissioner Schiermeyer seconded the motion and on roll call the following voted YEA: Friesen, Mercer, Schiermeyer, Handy and Mayor Adelung. Voting NAY: none.

Mayor Adelung introduced Ordinance 2703-07:

AN ORDINANCE TO AMEND THE OFFICIAL ZONING MAP OF THE CITY OF NEBRASKA CITY, AS REFERRED TO IN SECTION 403 OF ORDINANCE NO. 2040-88, BY CHANGING THE ZONING CLASSIFICATION OF THE: S49.5 feet of Lot 7; S49.5 feet of the W ½ of Lot 8; and the N30.5 feet of Lot 7 and the N30.5 feet of the W ½ of Lot 8; all in Block 88: and Tract A; Hershey Subdivision, Block 88, Nebraska City Proper; Otoe County, Nebraska, FROM R-2 RESIDENTIAL TO I-1 LIGHT INDUSTRIAL DISTRICT; TO PROVIDE INCORPORATION INTO THE OFFICIAL ZONING MAP OF THE CITY; TO PROVIDE FOR THE REPEAL OF ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT WITH THIS ORDINANCE; AND TO PROVIDE FOR AN EFFECTIVE DATE. and moved that the statutory rule requiring reading on three different days be suspended.
