MINUTES OF CITY COUNCIL SPECIAL MEETING
May 18, 2017

Pursuant to due call and notice thereof, a Special Town Hall Meeting of the City Council of the City of Nebraska City was conducted in the Kimmel Room of the Morton James Public Library, on May 18, 2017. Notice of the meeting was given in advance thereof by posting in at least three public places, the designated method for giving notice, as shown by the Certificate of Posting Notice attached to these minutes. Availability of the agenda was communicated in advance to the media, Mayor and Commissioners of this proceeding and said meeting was open to the public.
