MINUTES OF CITY COUNCIL SPECIAL MEETING
November 6, 2018

Pursuant to due call and notice thereof, a Regular Meeting of the City Council of the City of Nebraska City was conducted in the William F. Davis Room at City Hall, 1409 Central Avenue, on November 6, 2018. Notice of the meeting was given in advance thereof by posting in at least three public places, the designated method for giving notice, as shown by the Certificate of Posting Notice attached to these minutes. Availability of the agenda was communicated in advance to the media, Mayor and Commissioners of this proceeding and said meeting was open to the public.

Mayor Bequette called the meeting to order at 6:00 PM. Mayor Bequette publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and indicated the location of such copy posted in the room where the meeting was being held. Mayor Bequette then led in the Pledge of Allegiance. Upon roll call the following answered present: Paul Davis, Patrick Wehling, Vic Johns, Gloria Glover and Mayor Bequette. Absent: None. Moved by Commissioner Wehling and seconded by Davis to approve receipt and expenditure up to the amount of \$56,000.00 or the total amount of the project in donated funds for the purpose of constructing a new warning track on the Clemmy Holmes Field and to proceed with donor request of using Odeys as contractor and donor to pay any overages that may occur in excess of the \$56,000.00. Commissioner Wehling and Tom Bales spoke to explain the request. Upon roll call the following voted YES: Johns, Wehling, Davis, Glover and Mayor Bequette. Voting NO: None. Motion carried.
