MINUTES OF CITY COUNCIL SPECIAL MEETING  
March 23, 2020

Pursuant to due call and notice thereof, a Special Meeting of the City Council of the City of Nebraska City was conducted in the Gary White Room at the ROWE Public Safety Building, 1518 Central Avenue and also via the Zoom online video conferencing platform pursuant to the Governor's Executive order #20-03, on March 23, 2020. Notice of the meeting was given in advance thereof by posting in at least three public places, the designated method for giving notice, as shown by the Certificate of Posting Notice attached to these minutes. Availability of the agenda was communicated in advance to the media, Mayor and Commissioners of this proceeding and said meeting was open to the public.

Mayor Bryan Bequette called the meeting to order at 6:00 p.m. The Mayor publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and indicated the location of such copy posted in the room where the meeting was being held. Mayor Bequette then led in the Pledge of Allegiance. Upon roll call the following answered present: Paul Davis, Patrick Wehling, Vic Johns, Gloria Glover and Mayor Bequette. Absent: None. The following City Officials were present: City Administrator Grayson Path, City Attorney Drew Graham, Police Chief David Lacy, Utilities Director Jeff Kohrs, Construction and Facility Manager Marty Stovall, Paramedic Manager Andrew Snodgrass and City Clerk-Treasurer Randy Dunster.

Moved by Commissioner Glover and seconded by Wehling to approve the March 16, 2020 City Council meeting minutes. Upon roll call, the following voted YES: Davis, Wehling, Glover and Mayor Bequette. Abstain: Johns. Voting NO: None. Motion carried.

Drew Graham led a discussion regarding the Board of Health purpose and authority in concert with the City Council.

Moved by Mayor Bequette and seconded by Wehling to approve issuing administrative leave for employees with the first ten days unpaid and not exempt our Emergency Responders. Drew Graham, Andrew Snodgrass and Chief David Lacy spoke on the topic. Upon roll call the following voted YES: Johns, Wehling, Glover, Davis and Mayor Bequette. Voting NO: None. Motion carried.

Council agreed to hold another Special Meeting on March 30, 2020.
