MINUTES OF CITY COUNCIL SPECIAL BUDGET MEETING
September 13, 2021

Pursuant to due call and notice thereof, a Special City Council Meeting of the City Council of the City of Nebraska City was conducted in the Gary White Memorial Room of the ROWE Safety Complex 1518 Central Ave, on September 13, 2021. Notice of the meeting was given in advance thereof by posting in at least three public places, the designated method for giving notice, as shown by the Certificate of Posting Notice attached to these minutes. Availability of the agenda was communicated in advance to the media, Mayor and Commissioners of this proceeding and said meeting was open to the public.

Mayor Bequette called the meeting to order at 6:00 P.M. The Mayor publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and indicated the location of such copy posted in the room where the meeting was being held. Mayor Bryan Bequette then led in the Pledge of Allegiance. Upon roll call the following answered present: Patrick Wehling, Gloria Glover and Mayor Bequette. Absent: Vic Johns and Paul Davis. Commissioner Davis arrived at 6:05pm.

Moved by Mayor Bequette and seconded by Wehling to direct the City Administrator to draft a letter stating that the City is signing off on the reassignment of the Franchise Agreement from Spiral Communications to Pinpoint Communications, Inc. and approve the City Administrator to sign. Tom Shoemaker spoke to explain the request. Upon roll call, the following voted YES: Glover, Davis, Wehling and Mayor Bequette. Voting NO: None. Motion carried.

Lou Leone explained the progress made in the search to fill the City Attorney position and the next steps in the interviewing and hiring process.
