MINUTES OF CITY COUNCIL SPECIAL BUDGET MEETING  
August 3, 2022

Pursuant to due call and notice thereof, a Special Budget Discussion Meeting of the City Council of the City of Nebraska City was conducted in the Gary White Memorial Room of the ROWE Safety Complex 1518 Central Ave, on August 3, 2022. Notice of the meeting was given in advance thereof by posting in at least three public places, the designated method for giving notice, as shown by the Certificate of Posting Notice attached to these minutes. Availability of the agenda was communicated in advance to the media, Mayor and Commissioners of this proceeding and said meeting was open to the public.

Mayor Bequette called the meeting to order at 8:31 A.M. The Mayor publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and indicated the location of such copy posted in the room where the meeting was being held. Moved by Commissioner Wehling and seconded by Glover to approve minutes from the August 2, 2022 Special City Council Budget Meeting. Upon roll call, the following voted YES: Osovski, Glover, Wehling and Mayor Bequette. Voting NO: None. Motion carried.

The Council reviewed the highlights from the previous meeting then discussed departmental budgets for Recreation, Pool, Parks, Golf and Public Properties.
