Pursuant to due call and notice thereof, a Regular Meeting of the City Council of the City of Nebraska City was conducted in the Gary White Memorial Room of the Rowe Safety Complex, 1518 Central Avenue and by video conference on the Zoom meeting platform, on February 6, 2023. Notice of the meeting was given in advance thereof by publication in the local paper and by posting in at least three public places, the designated method for giving notice, as shown by the Certificate of Posting Notice attached to these minutes. Council discussed the error in the budgeted salary lines for Pool and Golf Departments to be aware of going forward.

Council provided unanimous consent to approve the reallocation of job duties for City Hall Staff as drafted. Commissioner Sharp, Marty Stovall and Randy Dunster spoke to explain the item.

Moved by Mayor Bequette and seconded by Wehling to approve adjusting the Step pay of the Account Clerk from Step 5 to Step 8 effective immediately. Upon roll call the following voted YES: Chaney, Wehling, Sharp, Osovski and Mayor Bequette. Voting NO: None. Motion carried.
