Pursuant to due call and notice thereof, a Regular Meeting of the City Council of the City of Nebraska City was conducted in the Gary White Memorial Room of the Rowe Safety Complex, 1518 Central Avenue and by video conference on the Zoom meeting platform, on February 20, 2023. Notice of the meeting was given in advance thereof by publication in the local paper and by posting in at least three public places, the designated method for giving notice, as shown by the Certificate of Posting Notice attached to these minutes. The agenda was made available via the City Website and communicated in advance to the media, Mayor and Commissioners of this proceeding and said meeting was open to the public.

AN ORDINANCE OF THE CITY OF NEBRASKA CITY, NEBRASKA CREATING STREET IMPROVEMENT DISTRICT NO. 2023-1; DEFINING THE BOUNDARIES AND LIMITS THEREOF; PROVIDING FOR PAVING, GRADING, CURBING, GUTTERING AND OTHER NECESSARY AND INCIDENTAL WORK; APPROVING PLANS, SPECIFICATIONS, AND ESTIMATES OF COST; PROVIDING FOR THE SECURING OF BIDS; PROVIDING FOR THE PAYMENT OF SUCH IMPROVEMENTS AND OTHER INCIDENTAL EXPENSES BY THE ISSUANCE OF WARRANTS, BOND ANTICIPATION NOTES AND BONDS; PROVIDING THAT NO PROPERTY WILL BE SPECIALLY BENEFITED BY SUCH IMPROVEMENTS AND PROVIDING FOR THE LEVY OF GENERAL TAXES; PROVIDING FOR THE PUBLICATION OF THIS ORDINANCE IN PAMPHLET OR ELECTRONIC FORM; AND RELATED MATTERS.

AN ORDINANCE AUTHORIZING THE ISSUANCE AND SALE OF BOND ANTICIPATION NOTES, SERIES 2023, OF THE CITY OF NEBRASKA CITY, NEBRASKA, OF THE PRINCIPAL AMOUNT OF NOT TO EXCEED TWO MILLION FIFTY THOUSAND DOLLARS (\$2,050,000) FOR THE PURPOSE OF PROVIDING INTERIM FINANCING FOR A PORTION OF THE COSTS OF CONSTRUCTING IMPROVEMENTS IN STREET IMPROVEMENT DISTRICT NO. 2023-1 OF THE CITY PENDING THE ISSUANCE OF PERMANENT GENERAL OBLIGATION BONDS; PRESCRIBING THE FORM OF SAID NOTES; AGREEING TO ISSUE GENERAL OBLIGATION BONDS TO PAY THE NOTES AT MATURITY OR TO PAY THE NOTES FROM OTHER AVAILABLE FUNDS; ENTERING INTO A CONTRACT ON BEHALF OF THE CITY WITH THE HOLDERS OF SAID NOTES; AND ORDERING THIS ORDINANCE PUBLISHED IN PAMPHLET OR ELECTRONIC FORM.

Moved by Mayor Bequette and seconded by Sharp to approve the Rural Work Force Housing Grant Commitment Letter to NDED and authorize Commissioner Sharp to sign. Kelly Gentrup from SENDD and Marty Stovall spoke to explain this item. Upon roll call the following voted YES: Chaney, Wehling, Sharp, Osovski and Mayor Bequette. Voting NO: None. Motion carried.

Moved by Commissioner Wehling and seconded by Osovski to approve the Request for Proposals for the Comparable Pay Study. Marty Stovall spoke to explain the item. Upon roll call, the following voted YES: Osovski, Wehling, Chaney, Sharp and Mayor Bequette. Voting NO: None. Motion carried.

Moved by Commissioner Chaney and seconded by Osovski to approve award 2022 1st Corso Improvements to Pavers Inc. Waverly Nebraska in the amount of \$788,992.25. Marty Stovall spoke to explain the item. Upon roll call, the following voted YES: Osovski, Wehling, Chaney, Sharp and Mayor Bequette. Voting NO: None. Motion carried.

Council discussed financing options for the Clint & Kim Kreifels subdivision. Marty Stovall and Jeff Kohrs spoke to explain the item. Council approved to move forward with Bond Council.

Moved by Commissioner Wehling and seconded by Sharp to approve JEO Task Order No. 23-02 Phase I Engineering for Sports Complex in the amount of \$76,000. Nick Schmitz spoke to explain the item. Upon roll call, the following voted YES: Osovski, Wehling, Chaney, Sharp and Mayor Bequette. Voting NO: None. Motion carried.

Moved by Mayor Bequette and seconded by Osovski for the Council to go into closed session for the protection of public interest specifically under the Open Meetings Act Subparagraph E for the Community Trust created under section 81-1801.82 discussion regarding amounts to be paid to individuals who have suffered from a tragedy of violence, and be joined by the Interim City Administrator Marty Stovall and the Chief of Police David Lacy. Council began the closed session at 7:32 PM.

Council came out of closed session and resumed the Open Session at 7:51 PM stating that no action was taken during closed session. Moved by Mayor Bequette and seconded by Wehling for the Council to deny the claim by Mr. & Mrs. Roth for approximately \$6,600.00 to the City.
