### ANNUAL PET LICENSE FORM INSTRUCTIONS:

1. PLEASE COMPLETE THE ABOVE FORM BY PROVIDING YOUR NAME, ADDRESS, PHONE NUMBER AND INFORMATION ABOUT YOUR PET.
2. BRING THIS FORM AND A COPY OF YOUR PET'S UPDATED RABIES VACCINATION TO CITY HALL TO LICENSE YOUR PET.
3. IF YOU HAVE ANY QUESTIONS, OR NEED ANY HELP PLEASE CALL OUR OFFICE AT **(402) 873-5515. CITY HALL IS OPEN MONDAY - FRIDAY FROM 8:00 AM TO 5:00 PM AT 1409 CENTRAL AVENUE IN NEBRASKA CITY.**
4. IF YOU HAVE MORE THAN ONE PET, WE HAVE ADDITIONAL LICENSE FORMS AVAILABLE AT CITY HALL OR YOU MAY MAKE COPIES OF THIS FORM.

Please remember that it is important to license your pet with City Hall for the following reasons:

1. It ensures that your pet has been vaccinated and is a healthy animal.
2. When your pet has updated vaccinations and is licensed it provides a safer environment for your pet and also for the people around your pet.
3. A licensed pet can be quickly identified if it becomes lost and the owner can be notified immediately of their pet's condition and location.

**If you live within Nebraska City's two mile jurisdiction or outside the corporate limits, you are also welcome to license your pet for identification purposes.**

**PET ORDINANCES FOR OWNERS IN THE LIMITS OF NEBRASKA CITY:**

**Sec 7-33 License Required.**

It shall be the duty of every person owning, keeping or harboring a dog or a cat to obtain a license therefore annually.

	<b>Owner Under age 62</b>	<b>Owner age 62 and up</b>
<b>Pet Is Spayed/Neutered</b>	\$10.25	\$7.25
<b>Pet Is Not Spayed/Neutered</b>	\$30.25	\$25.25

**Sec 7-35 Vaccination Required.**

It shall be the duty of every person owning, keeping or harboring a dog or cat to have them vaccinated by a licensed veterinarian. The City accepts rabies vaccinations that are for one or two years.

**Sec 7-5 Animal Waste.**

It is the owner or keeper of any dog, cat or other animal to be responsible for removing and cleaning up any animal waste deposited on public walks, recreational areas or private property.

**Sec 7-51 Impoundment Fees.**

The owner of any dog, cat or other animal that is impounded by the Nebraska City Street Department or Nebraska City Police Department shall be subject to the following fees:

<b>1<sup>st</sup> Impoundment</b> (if animal is licensed)	\$25.00*
<b>1<sup>st</sup> Impoundment</b> (if animal is not licensed previously)	\$50.00*
<b>2<sup>nd</sup> Impoundment</b>	\$75.00*
<b>3<sup>rd</sup> Impoundment</b> and any ensuing impoundments	\$100.00*

**\*Please note that the owner may be subject to other fees, such as rabies vaccinations, boarding and licensing, if the animal is not in compliance with City Codes.**
