Pursuant to due call and notice thereof, a Special Budget Discussion Meeting of the City Council of the City of Nebraska City was conducted in the Gary White Memorial Room of the ROWE Safety Complex 1518 Central Ave, on August 7, 2023. Notice of the meeting was given in advance thereof by posting in at least three public places, the designated method for giving notice, as shown by the Certificate of Posting Notice attached to these minutes. Availability of the agenda was communicated in advance to the media, Mayor and Commissioners of this proceeding and said meeting was open to the public.

Mayor Bequette called the meeting to order at 8:10 A.M. The Mayor publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and indicated the location of such copy posted in the room where the meeting was being held. Mayor Bryan Bequette then led in the Pledge of Allegiance. Upon roll call the following answered present: Ron Osovski, Patrick Wehling, Joe Chaney, Cole Sharp and Mayor Bequette. Absent: None. The Council discussed Fire Department, Police Department, Wildwood Historic House and Nebraska City Utilities. Gloria Glover spoke regarding the Budget preparations.

Moved by Mayor Bequette and seconded by Wehling for the Council to go into closed session for the protection of public interest specifically under the Open Meetings Act, the Committee Trust created under section 81-1801 for discussion regarding the amounts to be paid to Officers and Sergeants and the Dispatcher and because that is under negotiation and be joined by the City Administrator, Chief of Police, City Treasurer and City Clerk. Council began the closed session at 9:00 AM. Council came out of closed session and resumed the Open Session at 9:37 AM stating that no action was taken during closed session. No further action was taken.

At 10:05 AM, a brief recess was announced, council resumed at 10:11 AM.

Moved by Commissioner Wehling and seconded by Chaney to approve the Equipment/Project Request, (EPR), scoresheet as currently proposed on the spreadsheet and discussed by the Mayor to be funded through excess General Fund dollars in the amount of \$276,766.35. Upon roll call, the following voted YES: Osovski, Sharp, Wehling, Chaney and Mayor Bequette. Voting NO: None. Motion carried.
