## CITY OF NEBRASKA CITY, NEBRASKA MINUTES OF CITY COUNCIL REGULAR MEETING September 18, 2023

Pursuant to due call and notice thereof, a Regular Meeting of the City Council of the City of Nebraska City was conducted in the Gary White Memorial Room of the Rowe Safety Complex, 1518 Central Avenue and by video conference on the Zoom meeting platform, on September 18, 2023. Notice of the meeting was given in advance thereof by publication in the local paper and by posting in at least three public places, the designated method for giving notice, as shown by the Certificate of Posting Notice attached to these minutes. The agenda was made available via the City Website and communicated in advance to the media, Mayor and Commissioners of this proceeding and said meeting was open to the public.

Mayor Bryan Bequette called the meeting to order at 6:30 P.M. The Mayor publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and indicated the location of such copy posted in the room where the meeting was being held and stated that the meeting was being conducted under the Open Meetings Act. Total City of Nebraska City and Utility funds \$27,540,785.36. Council acknowledged receipt of City Administrator Report. Perry Mader spoke regarding the report.

Council acknowledged receipt of Utility Financial Report for period ending July 2023.

Council acknowledged receipt of Utility Claims for period ending August 2023.

Moved by Mayor Bequette and seconded by Osovski that the statutory rule requiring reading on three different days be suspended. Upon roll call the following voted YES: Chaney, Wehling, Sharp, Osovski and Mayor Bequette. Voting NO: None. Motion carried. Mayor Bequette declared that the motion adopted by three fifths vote of the council and the statutory rule suspended for the consideration of said ordinance.

Moved by Mayor Bequette and seconded by Osovski for final passage of **Ordinance 3106-23** to approve a request for Property Rezone of 716 South 6<sup>th</sup> Street from R-O to I-1. Upon roll call the following voted YES: Chaney, Wehling, Sharp, Osovski and Mayor Bequette. Voting NO: None. Motion carried.

## ORDINANCE NO. 3106-23

AN ORDINANCE TO AMEND THE OFFICIAL ZONING MAP BY CHANGING THE CLASSIFICATION OF THE ZONING DISTRICT OF THE PROPERTY AT 716 S 6TH STREET, NEBRASKA CITY, NE, AS MORE SPECIFICALLY DESCRIBED HEREIN, FROM R/O, RESIDENTIAL/OFFICE, TO I-1, LIGHT INDUSTRIAL; TO PROVIDE FOR INCORPORATION INTO THE OFFICIAL ZONING MAP; AND TO PROVIDE FOR AN EFFECTIVE DATE.

Council discussed a request from Karen Stigge to be granted Right-of-Way easement access to parcel 0004661000 and resolved to review options with regard to possible sale or lease of land and possible trail definitions with the City Attorney. Karen Stigge, David Ramold, Dan Nastase and Randy Dunster spoke on the item.

Moved by Commissioner Osovski and seconded by Wehling to approve the SDL request from the Fraternal Order of Eagles Aerie #968 for a benefit fundraiser event to be held on October 14, 2023 from 6:00am to midnight at the Fraternal Order of Eagles Aerie #968. Precilla McGinnis spoke to explain the request. Upon roll call, the following voted YES: Osovski, Wehling, Chaney, Sharp and Mayor Bequette. Voting NO: None. Motion carried.

Moved by Commissioner Chaney and seconded by Osovski to approve the request from Taylor Furnas to use the Sunken Parking lot for a Trunk-or-Treat event from 5:30 PM to 8:30 PM on October 22, 2023. Dan Mauk spoke to explain the request. Upon roll call, the following voted YES: Osovski, Wehling, Chaney, Sharp and Mayor Bequette. Voting NO: None. Motion carried.

Moved by Commissioner Sharp and seconded by Chaney to approve **Resolution 2945-23** to set the FY23/24 final property tax rate for the General Fund and the Bonded Indebtedness Fund. Moved by Commissioner Chaney and seconded by Osovski to approve **Resolution 2947-23** to approve the Placement of Additional Stop Signs at 7<sup>th</sup> Street and 2<sup>nd</sup> Ave. Upon roll call, the following voted YES: Osovski, Wehling, Chaney, Sharp and Mayor Bequette. Voting NO: None. Motion carried.

Moved by Mayor Bequette and seconded by Wehling to approve **Resolution 2948-23** to update the EMS Rates for fiscal year 23/24. Upon roll call the following voted YES: Chaney, Wehling, Sharp, Osovski and Mayor Bequette. Voting NO: None. Motion carried.

Mayor Bequette called for the first reading of **Ordinance 3107-23** to amend chapter 2 article VI of the City Code regarding EMS Lift Assist cost recovery.

Moved by Commissioner Sharp and seconded by Wehling to approve **Resolution 2949-23** to approve the FY23/24 Step Pay Schedule for City Employees. Upon roll call, the following voted YES: Osovski, Wehling, Chaney, Sharp and Mayor Bequette. Voting NO: None. Motion carried.

Council tabled the discussion to approve the Demolition Permit Application for 516 N 13<sup>th</sup> Street since it had been previously approved at the August 7, 2023 City Council Meeting and this application was the processing of the paperwork to complete the project.

Moved by Commissioner Osovski and seconded by Wehling to approve an engineering evaluation on the proposed floodwater mitigation and wastewater plant expansion project. Jeff Kohrs spoke to explain the request. Upon roll call, the following voted YES: Osovski, Wehling, Chaney, Sharp and Mayor Bequette. Voting NO: None. Motion carried.

Moved by Commissioner Chaney and seconded by Sharp to approve to award bid to Bauer Infrastructure, LLC for the Kreifels Hills Subdivision project in the amount of \$2,273,419.50. Marty Stovall spoke to explain the item. Upon roll call, the following voted YES: Osovski, Wehling, Chaney, Sharp and Mayor Bequette. Voting NO: None. Motion carried.
