## CITY OF NEBRASKA CITY, NEBRASKA MINUTES OF CITY COUNCIL REGULAR MEETING November 20, 2023

Pursuant to due call and notice thereof, a Regular Meeting of the City Council of the City of Nebraska City was conducted in the Gary White Memorial Room of the Rowe Safety Complex, 1518 Central Avenue and by video conference on the Zoom meeting platform, on November 20, 2023. Notice of the meeting was given in advance thereof by publication in the local paper and by posting in at least three public places, the designated method for giving notice, as shown by the Certificate of Posting Notice attached to these minutes. The agenda was made available via the City Website and communicated in advance to the media, Mayor and Commissioners of this proceeding and said meeting was open to the public.

Mayor Bryan Bequette called the meeting to order at 6:00 P.M. The Mayor publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and indicated the location of such copy posted in the room where the meeting was being held and stated that the meeting was being conducted under the Open Meetings Act. Mayor Bequette opened the Public Hearing on the intent to use \$115,876.00 of the Nebraska City Economic Development Plan Growth Funds for the Nebraska City Creative District for the continuation and expansion of the Flower Basket Program. Dan Mauk, Kelly Bequette and Jim Kuhn spoke in favor of the request. No other comments were made by the public. Mayor Bequette moved to close the Public Hearing, seconded by Commissioner Osovski. Treasurer's Monthly report was given, as of October 31, 2023, Total Nebraska City funds of \$12,835,177.51. Total Cash and Reserve for Nebraska City Utilities of \$14,775,507.36. Total City of Nebraska City and Utility funds \$27,610,684.87. Council acknowledged receipt of City Administrator Report. Perry Mader spoke regarding the report. Council acknowledged receipt of Utility Claims for period ending October 31, 2023.

Moved by Commissioner Osovski and seconded by Wehling to amend and approve minutes from the November 6, 2023 City Council Meeting and amend the last item to read, "to designate \$100,000.00 out of the \$170,177.97 left in the General Reserve Fund to establish a Capital Improvement Fund and put the remainder, \$70,177.97 in the Equipment Reserve Fund which has already been established.". Upon roll call the following voted YES: Chaney, Wehling, Sharp, Osovski and Mayor Bequette. Voting NO: None. Motion carried.

Moved by Commissioner Osovski and seconded by Chaney to approve **Resolution 3111-23** on the intent to use \$115,876.00 of the Nebraska City Economic Development Plan Growth Funds for the Nebraska City Creative District for the continuation and expansion of the Flower Basket Program. Upon roll call the following voted YES: Chaney, Wehling, Sharp, Osovski and Mayor Bequette. Voting NO: None. Motion carried.

Moved by Mayor Bequette and seconded by Osovski that the statutory rule requiring reading on three different days be suspended.
